Hi Bonny,

I had a quick look at the drawings for the Vista Mar project this morning. The drawings seem to be missing the overall project exterior elevations and rendering? Can those be found elsewhere? The civil drawings seem to show less trees being taken out, but as the building footprints don't appear to have moved, I think they are just not shown. Is there a separate plan for the logging they are proposing?

It doesn't look like the project has changed in any meaningful way in relation to my previous comments about grading, drainage, amount of impermeable site areas, parking or trees. Can you comment?

It sounds like the project will be deferred to the meeting in August, which I appreciate as it will give us more time to review the plans in detail and give feedback to the commission. Several other neighbors have expressed concern to me as well.
